**What a great fight by Comrades of SNEA(I) / Kolar:**

Comrades of Kolar (Karnataka) staged a great, spirited and prolonged organizational fight to expose the mala fide intentions of GM/Kolar in victimizing our District Secretary,, Com Narain Nandakumar, JTO/Mulbagal.

Acting on a fabricated and fictitious complaint against Com Narain Nandakumar, GM / Kolar transferred arbitrarily our District Secretary to remote area in August, 11, besides initiating other unwarranted actions against him. Since then our brave and determined Comrades of Kolar have been tirelessly fighting against vindictive and malafide actions of GM/Kolar who was supported by some vested interests at Kolar.

The whole struggle at Kolar was led in a truly commendable manner by Com. Nagavi, our CS/Karnataka, by not only getting involved fully in the struggle but continuously encouraging our Comrades of Kolar to continue their struggle despite continuous vindictive attitude of GM / Kolar. It was really a testing time for unity of Comrades of Kolar since struggle stretched over four months but our Comrades did not lose their conviction and maintained rock like unity despite all possible methods employed by GM / Kolar and his cronies to disintegrate unity of our Kolar Comrades.

Com Nagavi, CS / Karnataka, took up the issue with CGM / Karnataka who constituted a committee to inquire into the fabricated charges. Inquiry committee virtually found all the allegations against our District Secretary untrue but yet due to narrow fraternal ITS weaknesses CGM / Karnataka did not intervene in any way even though inquiry committee constituted by him only found all the allegations untrue.

GS also had a detailed discussion with then Director ( HR ) on the issue apprising him of all the facts and urging upon him to act but because of narrow fraternal ITS considerations he too did not intervene. That is how ITS has been losing the confidence of people in administration of justice.

Finally, under able guidance and leadership of Com Nagavi, a case was filed by our District Secretary in Hon.CAT / Bangalore for setting aside of the transfer order. Initially, Hon.CAT / Bangalore directed GM / Kolar to consider representation of Com Nandakumar but as expected GM / Kolar rejected his representation.

Finally, Hon. CAT / Bangalore, in NOV.,11 after hearing detailed arguments from both the sides for about four months, set aside the transfer order virtually indicting GM / Kolar on the grounds of malafide holding that transfer cannot be issued as a consequence of punishment. This is not only an indictment of GM / Kolar, but of CGM / Karnataka and Director (HR) too for their deliberate inaction TO ACT AGAINST GM / Kolar on the basis of narrow fraternal ITS considerations. Comrade Narain Nandakumar, our hero of Kolar, has honorably joined back at Mulbagal.

Heartiest congratulations, Com Nagavi, Com Nandakumar and our brave heroes of Kolar for great and spirited fight put up by you in exposing fully ITS controlled management for its vindictive, arbitrary and mala fide actions and also parochial ITS considerations. Com Nagavi and Comrades of Kolar- you have lifted the pride of the Association to great heights and set up a great example of what prolonged, committed and sustained fight against injustice means and where it finally leads to - Really great.
