The officiating arrangements ordered above are made in the interest of service and subject to the following conditions.

The officiating arrangements are for a minimum period of 31 days or till a regular incumbent joins or until alternate arrangements are made whichever is earlier & are upto 08.11.2012 or till a regular incumbent joins or until alternate arrangements are made whichever is earlier.

a) In case of the executives who are due for retirement before 08.11.2012, the officiating promotion in SDE (T) is for a period upto their date of retirement or till a regular incumbent joins or until alternate arrangements are made whichever is earlier.

(b) In case of Executives belonging to reserved community, the correctness of the community may be verified once again by the respective unit heads before implementation of the orders.

(c) In case any disciplinary/vigilance case is pending against the Executive now promoted, promotion of such Executive should not be given effect to and full facts be reported to this office.

(d) The Executives ordered on officiating promotion shall report for duty within 10 days from the date of issue of this order. All the controlling officers are requested to see that the Executives ordered on officiating promotion above are relieved immediately to expedite implementation of order in the interest of service.

(e) Any request for change of posting will not be entertained. In case any of the Executive is not willing and does not join the new post as stated above, the officiating arrangement will automatically stand cancelled in respect of the Executive and the Executive will not be considered for further local officiating promotion for a period of one year from the date of issue of this order.

(f) In case any of the Executive is not willing to take up the assignment due to any reason, the same may be obtained in writing from such Executive and forwarded to this office immediately.

(g) On expiry of the officiating arrangements in SDE (T), the Executives will report back to their original posts. SSA Heads may relieve the Executives to their original post on expiry of the officiating arrangements without waiting for any instructions from Circle office and the relinquishing charge report of the Executives may be sent to this office in one bulk.

(h) In case of executives who are issued with time bound promotion and already placed in the upgraded IDA pay scale of SDE they are not eligible for any pay fixation benefits on account of above officiating promotion and their pay fixation will be as per the guidelines issued vide BSNL ND letter Nos. 400-61/2004-Pers.I/308 dtd. 18.01.2007 and 400-29/2007- pers. I dtd. 30.5.2007. In case of others, pay may be fixed in the revised IDA pay scale as per BSNL Hq. ND No. 1-50/2008-PAT (BSNL) dated 05.03.2009.

Necessary Charge reports may be furnished to all concerned and Consolidated report of joining/relieving/declining of JTOs of the respective SSAs may be furnished to this office immediately.
