
Sub: Grant of Special CL to attend CWC meeting at Chennai to be held on 7th and 8th Jan 2013.



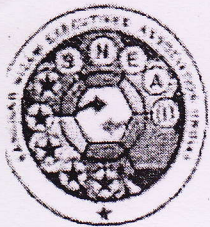
